## **SEEKING AN ADEQUATE SHELTER ALLOWANCE**

Scott Martin, Robert Polemeni (Weil, Gotshal & Manges LLP) and Adam Grant (formerly with Weil) have worked tirelessly as co-counsel on *Brownley v. Doar*, an action seeking to require New York State to adopt an adequate public assistance shelter allowance for families with children in New York City who receive assistance in the "Safety Net" category because they have reached the five-year time limit on federally reimbursed assistance. Although originally successful at the trial level, the trial court later dismissed the case on the authority of a decision by the Appellate Division, Second Department involving families in Westchester County. #### REPRESENTATION OF IMMIGRANT JUVENILES

Amadou Ly, an 18-year-old immigrant from Senegal who was facing deportation, was granted a student visa on July 28, allowing him to stay in the United States and attend college. Wilmer Cutler Pickering Hale and Dorr LLP; Latham & Watkins LLP and Weil, Gotshal & Manges LLP served as co-counsel with the Society on the case. Amadou came to the United States in 2001 on a tourist visa. One year later, his mother returned to Dakar, instructing the 14-year -old to stay behind and receive an education. He was in his junior year of highschool when deportation proceedings were first brought against him. Amy Meselson, a Legal Aid Society lawyer, became aware of Ly's case after he showed up at Immigration Court alone. Meselson has been a driving force behind the creation of a special monthly docket for juveniles at Immigration Court. The New York Times published a story on Ly's immigration troubles on April 26, after his robotics team unexpectedly beat out the city's elite high schools to win a place in a nation-wide robotmaking competition. The subsequent success of the case was covered by the New York Times on July 28.

## PROTECTING THE RIGHTS OF THE DISABLED

## PROTECTING THE RIGHTS OF IMMIGRANTS
